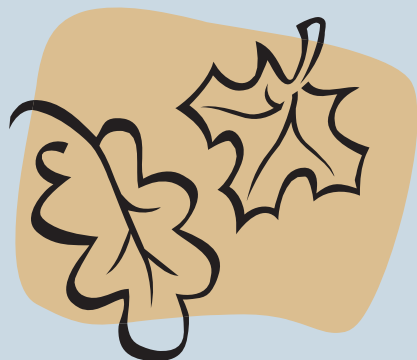

Don't Delay!

Each year the State of Texas requires that we validate any account we hold that has no activity **for 60 months**. Once an account reaches this stage you must tell us in writing that you want to keep the account or it will be closed and sent to the STATE! Please don't be one of these! If you get a letter from the Credit Union, respond immediately in one of the following ways (deadline is October 28, 2011):

- **Sign the letter and mail back**
- **Fax the letter (or a hand-written note by you) to 806-353-2533**
- **Call or come in to either office here in Amarillo.**
