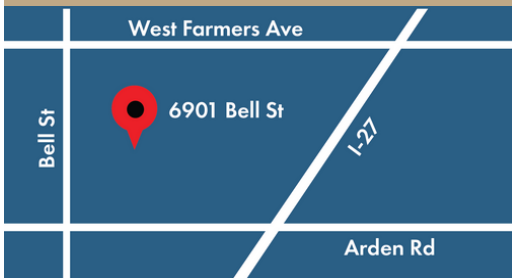

It will be the duty of the Nominating Committee to nominate at least one member for each board vacancy. Any member in good standing who meets the eligibility requirements may petition to be included on the ballot. The petition must be signed by a minimum of 1% of members eligible to vote as of year-end 2025. The petition must be submitted to the nominating committee by March 13th, 2026 (40 Days prior to the annual meeting). If only one member is nominated for each position to be filled, a voice vote may be taken, or the Chairman of Board or CEO may declare each nominee elected by general consent or acclamation at the Annual Meeting. There will be no nominations from the floor.
