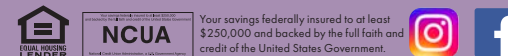

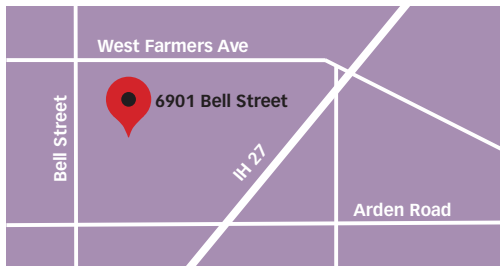

When only one member is nominated for each position to be filled, a voice vote (not by ballot) may be taken or the Chairman of board or CEO may declare each nominee elected by general consent or acclamation at the Annual Meeting.
