- If your loan has a co-signer, both parties must sign the request.
- ACCU reserves the right to deny any Skip-A-Payment request, including loans involved in bankruptcy.

I understand the Skip-A-Payment option in no way alters the terms and conditions of my original loan contract as previously disclosed. Interest at the agreed rate will continue to accrue on the unpaid balance of my loan. Loan payments made by payroll deduction will be deposited to the share account. Please be advised that if you have GAP coverage on your loan(s) and elect to participate in the Skip-A-Payment Program, future claims may be reduced by the amount of deferred (skipped) payments.

***I understand that all loans I elect to defer must be in the same month.*** I understand that the application fee is for participating in the plan regardless of whether I elect to skip any payment.

I understand and agree with the above terms, and request that you skip any payment(s), requested in this application, based on the appropriate pay method of payroll deduction, cash payment, automatic transfer, or bank draft.
